Boat Race Waiver, Indemnification and Release of Liability

In consideration of being allowed to participate in any way in the above race, the undersigned, for him/herself, his/her personal representatives, heirs, next of Kin:

- 1. Agrees that prior to participating, he/she will inspect the facilities and equipment to be used, and if he/she believes anything is unsafe, he/she will immediately advise the race officials of such condition(s) and refuse to participate.
- 2. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses to person or property which might result not only from his/her own actions, inactions or negligence, but also the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not know to us or not reasonably foreseeable at this time.
- 3. Assumes all the foregoing risks and accepts personal responsibility for any and all loss, liability, damages or costs following such injury, permanent disability or death,
- 4. Releases, waives, discharges, and covenants not to sue the Ridley Township Marina (start/finish line/parking), the Darby Creek Valley Association (race supporter), Susan Miller (race organizer); Jaclyn Rhoads (race coordinator), registrars, timers, safety boaters, and other race helpers; referred to as "releasees," from any and all claims, liability, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.
- 5. Agrees to indemnify and save and hold harmless the releasees from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in any way competing, officiating, observing, or working for, or for any purpose participating in the event.
